Over the years we have covered these 'white spots' with data from other sources, but we have now reached a stage where they greatly outnumber the countries that do supply data.

While we review the situation and reflect on the future format of the European Coffee Report, we hereby present a limited version with the European data.

NOTE ON THE TABLES

Bags are bags of 60 kilos Tons are metric tons

The recalculation of roasted and soluble coffee uses the conversion factors as approved under the International Coffee Agreement 2007 (ED 2123/11 of 20 October 2011):

- from roasted to green: multiply by 1,19
- from soluble to green: multiply by 2,6
- from green decaffeinated to green: multiply by 1,05

Green coffee equivalent is the sum total of the volume of green, green decaffeinated, roasted and soluble coffee recalculated to green coffee with the above conversion factors.

In the notation of figures, the convention of continental Europe is followed:

- thousands are separated by a dot (.)
- the decimal sign is the comma (,)

For large numbers the so-called 'long scale' is used: 10^6 = one million, 10^9 = one milliard, 10^{12} = one billion, 10^{15} = one billiard, 10^{18} = one trillion, etc


Abbreviations of currencies are those used for international banking purposes, based on ISO standards.


GREEN COFFEE STOCKS IN MAJOR EUROPEAN COFFEE PORTS

THE EUROPEAN COFFEE MARKET IN 2012

1. IMPORTS AND EXPORTS

EU data refer to the 27-member European Union. The traditional division between 'Western Europe' and 'Central and Eastern Europe' has changed over time with the increasing EU membership. The terms 'Western Europe' and 'Central and Eastern Europe' are not strictly defined, and the inclusion of a country in one or the other group has always been somewhat arbitrary. We designate EU plus Norway and Switzerland as 'Western Europe'.

In calendar year 2012 green coffee imports in Western Europe were 54,8 million bags, a small increase of 1,6% compared to the almost 54 million bags in 2011. The Western European market is dominated by the EU. Green coffee imports into the EU27 – including intra-EU trade - increased by 1,8% from 51,2 million bags in 2011 to 52 million bags in 2012. Eurostat commonly corrects its data after initial publication, which means that there are some variations with the data in last year's report.

According to ICO data, Central and Eastern European imports of coffee in all forms in 2011 (the most recent year available for most of these countries) amounted to 7,2 million bags, 2,8% lower than the year before. Please note that the list of countries for Central and Eastern Europe has changed in line with available ICO statistics





In past years Brazil, Vietnam and Colombia were consistently the top-3 suppliers to the EU. While Brazil and Vietnam kept their positions in the 2009-2012 period, the third place changed from Colombia to Indonesia in 2009 and 2010, from Indonesia to India in 2011, and from India to Honduras in 2012. In 2012 Brazil continued to be the major green coffee supplier to the EU even though its volume dropped with almost 2 million bags and its market share with 4,7 percentage points to 27,2%. Vietnam retained its position as second supplier, with a considerably higher volume (2,9 million bags) and import share (25,8%). As mentioned, Honduras took third spot in 2012 with a seriously larger volume: +629.000 bags. The top-five was completed by Peru and India. It is worth observing to what extent two origins dominate EU imports: Brazil and Vietnam together represent over half of EU imports, more than the numbers three to twenty combined.

The next two graphs illustrate the changes in the 'top 5':





Being late in releasing this report has one small advantage: we can include the import data for the first six months of 2013. These are the top-20 origins of 2013, compared with the same origins in the first half of 2012:

Imports by type of coffee for the EU are now included in the European chapter. This is because data for each individual country are becoming less easy to determine. For intra-EU trade, the Eurostat country statistics do not reveal the country of production of green coffee. When arriving from the countries with major coffee ports, the origin may be recorded in the statistics as - say - Germany or Belgium. In many cases the share of the intra-EU trade is so high that no meaningful assessment can be made of the types of coffee imported. In order to have some idea of development in the EU as a whole, the following table has been added to this chapter:

The overall ratio Arabicas/Robustas has shifted somewhat towards Robustas. The lower Arabica share can be attributed mainly to the reduced import share of Brazil.

The EU is not only an important importer of green coffee, but also a significant exporter of finished products. The EU imports of green decaffeinated coffee and regular roasted coffee are modest compared to the exports

of the same products while the imports and the exports of decaffeinated roasted coffee and coffee extracts (soluble coffee) are fairly evenly matched.

Compared to 2011 the re-exports in 2012 of green coffee increased by 9,6%. The **exports** of green decaffeinated coffee decreased (-4,1%). Exports of roasted coffee were higher for regular (+10,7%) but lower for decaffeinated (-20,1%). Soluble coffee exports increased (+8,9%). Green decaffeinated **imports** decreased with 11,4% in 2012 compared to 2011. Imports of roasted coffee increased for regular (+8,2%) and decreased marginally for decaffeinated (-1%). Imports of soluble coffee decreased significantly with 21,9%.

Looking in some more detail at the EU exports of finished products, in the years 2010-2012 the twenty main destinations of roasted coffee (non-decaffeinated plus decaffeinated), listed according to their ranking in 2012, were:

In 2012 total exports of roasted coffee (including decaffeinated coffee) to non-EU destinations increased by 9,5% in volume compared to the previous year. Ukraine jumped to first place as the largest non-EU destination, but numbers two to four (respectively Russian Federation, United States and Switzerland) were roughly in the same order of magnitude.

Regarding the EU exports of soluble coffee (officially: extracts, essences and concentrates of coffee) to non-EU destinations, the total volume increased by almost 9%. In 2012 the three largest clients were the Russian Federation, Ukraine and Australia. In 2012 the Russian Federation regained its position as the major destination, having lost it to Ukraine in 2011. Even so, the share of the Russian Federation in EU soluble coffee exports (22% in 2012) remains far below that of 2010 (33%). Remarkable is the increased volume of exports to South Africa: 869 tons in 2010, 1190 tons in 2011 and 2709 tons in 2012, over three times as much. This made South Africa the fourth destination in 2012. In volume terms, listed according to their 2012 ranking, the 10 largest destinations in the three most recent years were:

Several coffee-producing countries have a sizeable production and export of soluble coffee. The following table, giving EU imports of soluble coffee from the five main non-EU origins, illustrates this: all but one of the five largest suppliers are coffee producing countries. Overall volume increased by almost 22%. In 2012 the top-three remained unchanged: Ecuador, Brazil and Switzerland. India and Colombia completed the top 5, but swapped places: India became the fourth supplier in 2012.

These data underline the economic relevance of the coffee sector for the EU food and drinks industry and trade balance. The value of the intra-EU trade of finished coffee products (roasted and soluble coffee) in 2012 was EUR 4,4 milliard. In comparison, the value of exports to non-EU destinations of finished coffee products was much smaller, but still represents a relevant contribution to the EU export performance: EUR 1,3 milliard. According to ICO data, the share of the EU in the value of imports (C.I.F.) of all forms of coffee by importing countries from all sources in 2012 was close to 65%, making the EU a significant trading partner of the coffee exporting countries.
